Eligibility

Competition is open to full- or part-time art students enrolled at Christopher Newport University, Hampton University, The College of William and Mary, Thomas Nelson Community College, Norfolk State University, Old Dominion University, Virginia Wesleyan University, and Tidewater Community College. Audit students are not eligible.

Entry Rules (Please read carefully)

1. All works must be **ORIGINAL**, that is, a unique image created by the student. Manipulations of copyrighted images and reproductions will not be accepted.
2. Each student may submit **two** entries.
3. Works in any medium are eligible.
4. Size restrictions, no more than: 24" x 30" inches for 2-dimensional works; 20" x 20" x 20" for 3-dimensional works.
5. Complete the entry form and attach identification label to the upper back (2-D) or bottom (3-D).
6. All work must have been completed during Summer 2016 or the 2016-17 school year.
7. All entries must be ready to exhibit. All 2-D works must be matted.
Students are encouraged to frame and wire their work for hanging. Or, work can be covered with clear acetate with NO hangers; they will be installed by PFAC with L-hooks. No sawtooth hangers.
8. No exhibited or sold works may be removed before the close of the exhibition.

Asa Jackson grew up on the peninsula and graduated from Hampton Roads Academy in 2007. Jackson is known for creating a wide range of paintings, sculptures, clothing designs and writings. After studying sociology at Boston University, Jackson moved to New York to pursue his art career. While living in New York, he participated in a number of group shows along the east coast. In 2012, he had his first solo exhibition at the Samuel Owen Gallery in Greenwich, CT. Since then, he has been living and working in Hampton Roads, and was recently featured on WHRO's the Scene and PBS Richmond's Virginia Currents. Jackson is the executive director of 670 Gallery, a contemporary art gallery in Hampton, Virginia.
