



By Land(scape) or By Water(color)

Call for Entries

The Peninsula Fine Arts Center announces a call for entries for their spring exhibition, *By Land(scape) or By Water(color)*.

How has landscape painting evolved? While artists awe at the magnificence of nature and the changing of seasons, some artists reflect on the concerns for the threat imposed on the landscape in the face of human habitation, industrialization and dwindling natural resources. Artists offer different ways of seeing and experiencing the land. With support from the Virginia Watercolor Society, this exhibition will offer visitors the opportunity to reflect on how we view the image of an ever-changing landscape.

Exhibition Dates: May 4 – 26, 2019

Eligibility: This exhibition on the subject of landscapes is open to artists who work in all media, including mixed media.

Entries: Each artist may submit up five works for jurying. Each work may be represented by two separate images: one full view and one detail view. Work must be submitted in high resolution digital format. For each entry please note: Title or description; Date of creation, Media; Size/Dimensions; Retail price or not for sale/insurance value.

Entry Deadline: January 18, 2019.

Conditions: All entries must be original and must be completed within the last 2 years. The Center reserves the right to reject entries that do not meet these requirements or is deemed unstable. Shipped work that differs from submitted images will not be accepted. Work damaged in shipping will regretfully not be displayed. All selected work must have proper identification. No selected work may be picked up before the closing of the exhibition. Work may be available for sale or must be identified as NFS. The retail price or insurance value provided on the entry form will be used; no changes may be made after the work is shipped.

Sales/Insurance: A 40% commission on all sales will be retained by the Center. Artists must indicate sale price and insurance value or, if NFS, just insurance value. Submission of work to this exhibit is done so at the artist's risk and implies an agreement on the part of the artist to all the conditions of this Call for Submission. PFAC will not be responsible for loss or damage to work in transit, however, work will be insured while in the Peninsula Fine Arts Center.

Shipping: Shipping costs are the responsibility of the artist.

Hand delivery of art is recommended, but shipping is available as an option for an additional labor charge of \$10.00. No COD arrangements may be made. Ship works to 101 Museum Drive, Newport News, VA 23606, 757-596-8175.

A check for return shipping, including the cost of insurance, must accompany delivered work, payable to Peninsula Fine Arts Center. Work damaged in shipping will not be displayed. Please check with carrier on recommended packing procedures. Detailed packing/unpacking/handling instructions must accompany all shipped or hand delivered works. Please label all exterior and interior boxes and crates with artist name and title of work.

Publicity: The Peninsula Fine Arts Center reserves the right to photograph entries for the purposes of documentation, education and publicity. Accepted artists are encouraged to send to the PFAC their résumé, artist statement, brochures, and additional photographic materials of the accepted work for publicity purposes.

Receiving Deadline: All work must be received no later than these dates.
