Eligibility

Competition is open to full- or part-time art students enrolled at Christopher Newport University, Hampton University, The College of William and Mary, Thomas Nelson Community College, Norfolk State University, Old Dominion University, Virginia Wesleyan University, and Tidewater Community College. Also eligible are art students that attend colleges and universities within the state of Virginia. Audit students are not eligible.

Entry Rules (Please read carefully)

1. All works must be **ORIGINAL**, that is, a unique image created by the student. Manipulations of copyrighted images and reproductions will not be accepted.
2. Each student may submit **two** entries.
3. Works in any medium are eligible.
4. Size restrictions, no more than: 24" x 30" inches for 2-dimensional works; 20" x 20" x 20" for 3-dimensional works.
5. Complete the entry form and attach identification label to the upper back (2-D) or bottom (3-D).
6. All work must have been completed during Summer 2019 or the 2019-2020 school year.
7. All entries must be ready to exhibit. All 2-D works must be matted.
Students are encouraged to frame and wire their work for hanging. Or, work can be covered with clear acetate with NO hangers; they will be installed by PFAC with L-hooks. No sawtooth hangers.
8. No exhibited or sold works may be removed before the close of the exhibition.

Responsibility

Although reasonable care will be taken, Peninsula Fine Arts Center does not assume responsibility for lost or damaged works.

Juror:

Kimberly McKinnis is an artist, educator, and curator originally from Southern California. She holds a BFA in Studio Art with a Concentration in Glass, and an MFA in Exhibition Design—both from the California State University in Fullerton, California. She has returned to making her own work, which focuses on themes of identity, introspection, and exploring preconceived notions of beauty through symmetry. In her personal studio practice, she utilizes a variety of media including silver, glass, video, and performance. Her work has been exhibited nationally and internationally and has been featured in publications such as the annual New Glass Review by the Corning Museum of Glass. She is a member of the glass studio team at the Chrysler Museum of Art.
